## Payment and Cancellation Policies:

**\$500 Reception Music Fee** (includes setup and 2 hours of music with 1, 10-15 minute break per hour for musicians. **\$200** per additional hour of music; mic will be available for toasts and speeches. Includes sound system, an in-depth meeting in person or via phone to discuss musical selections and wedding details, email consultations, and travel within 25 miles of Eugene/Springfield. Travel time outside greater Eugene area billed at \$100/hour, billed in 30 minute increments.

A deposit in the amount of \_\_\_\_\_ (50% of total, due at time of billing) made payable to Bradly Shepherd's Perfect Flavor, is required to guarantee the booking of this event. Remaining balance of \_\_\_\_\_ shall be paid prior to performance. Payment is accepted by cash, check, or cc payment via Square.

Cancellation: If cancellation is received 90 days prior to event, 75% of deposit is refundable or transferrable to another date, provided that one is available. If cancellation is received after the 90 days prior to event, deposit is non-refundable. If Perfect Flavor is unable to perform as a result of sickness, accidents, acts of God, or other reasons beyond Musician's control, deposit will be refunded in full.
